MEMBERSHIP AGREEMENT**

PAYMENT OF DUES: Members will be charged for the month in which they join, but not the month in which they end their membership. Checks, money orders, cash and credit cards (VISA and MasterCard) are accepted. Credit card payments must be made in person. Credit card payments cannot be accepted by telephone or in the mail.

RENEWAL: Timely payment of dues is a member responsibility. All renewals are payable in full by the last day of the month in which the membership expires, i.e., Jan 31, Feb 28, Mar 31, etc. Dues not paid by the 15th calendar day, after the expiration date will result in removal from the PAC membership. Locks will be cut (when applicable), and locker contents will be removed and placed in safekeeping. After 45 days the items will be removed from the PAC IAW DoD disposal regulations.

GUEST SERVICE FEE AND MEMBER RESPONSIBILITY: Guests may use the facilities when accompanied by a PAC member. Guest fee is **\$4**

RESIGNATION: Members are refunded prepaid dues based on notification of resignation. Refunds will not be paid to members whose membership is terminated for cause or who fail to follow the resignation procedure.
